1. Non- transferable.
2. Equipments supply shall follow the specifications of sample as stated in the test report(s) submitted to RND.
3. Any changes/additions from the original specifications shall be written in order to obtain approval from Fire And Rescue Department, Ministry Of Home Affairs, Negara Brunei Darussalam.
4. Specifications of equipments supply shall follow the conditions that are set by Fire And Rescue Department, Ministry Of Home Affairs, Negara Brunei Darussalam.
5. If there is amendment/renewal to the Conditions/Standards, Issuer/Distributor shall be given a specific period by Fire And Rescue Department to amend or change the original specifications of equipments following the needs of the new Standard conditions.
6. All equipments shall have the name of Issuer, serial number, date of supply and stamp recognised by Fire And Rescue Department, Ministry Of Home Affairs, Negara Brunei Darussalam.
7. Fire And Rescue Department, Ministry Of Home Affairs, Negara Brunei Darussalam reserves the right to select any equipment sample, which have been issued OR installed for testing and re-tested if required. All cost shall be beared by the Issuer.
8. Issuer/Distributor shall forward an authentic copy of Certificate Of Approval for the use of equipments distribution.
9. Issuer/Distributor shall forward STD 1/001 Form to Fire And Rescue Department, Ministry Of Home Affairs, Negara Brunei Darussalam for approval stating that they have conducted supervision/installation/supply e.g. Standards which are approved and recognised by CPRU, Ministry Of Development.
10. Architect or qualified persons responsible shall ensure and inspect all installation works carry out by the contractor and certify that the installation follows the correct procedure as stated in the test report(s).
11. If any query or evidence shows the failure of the equipments, they shall be reported immediately to Research And Development Section, Fire And Rescue Department, Ministry Of Home Affairs, Negara Brunei Darussalam.



12. Research And Development Officer can also make **spot check** at any time. The Supplier of the equipment shall bear the responsibility if it does not follow the specification.
13. The Certificate Of Approval shall not be published OR used for the purpose of promotion OR advertisement without written approval from Director of Fire And Rescue, Ministry Of Home Affairs, Negara Brunei Darussalam.
14. For the renewal of Approval Certificate, the application shall submit to Fire And Rescue Department **three months before the expiry date** of the Approval Certificate together with:-
  - Written Application.
  - Copy of the latest test report from Institute of Standard and Industrial Research Laboratory recognised by Fire And Rescue Department, Ministry Of Home Affairs, Negara Brunei Darussalam.
  - Make arrangement to provide facilities to evaluate inspection needs of all equipments in new consignment as sample.
  - List of Projects in which the equipment supply by the distributor/supplier during the year.
15. For the benefit of the public, Director of Fire And Rescue, Fire And Rescue Department, Ministry Of Home Affairs, Negara Brunei Darussalam has the right to withdraw the Certificate Of Approval at any time if required.
